INVESTMENT OBJECTIVE AND STRATEGY

UHDF seeks to provide long-term growth of capital appreciation and steady income stream through investments in domestic, listed common and preferred shares. It also aims to surpass its benchmark (gross of fees) which is the Philippine Stock Exchange Index (PSEi). This should not be construed, however, as a guarantee of yield.

CLIENT SUITABILITY

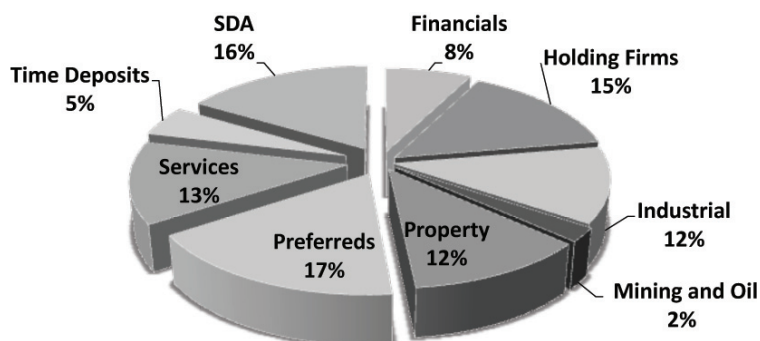
NAVPU Graph

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper amounting to P36k which was approved by the Board of Directors. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

PSEi inched up in December ending the year at 6,952 or 3.8% below the 2014 level. To recap, the PSEi rose to an all-time high of 8,127 in April only to reverse direction a few months after on renewed concerns over Greece's debt, a slowdown in China and uncertainty arising from the looming Fed rate hike. These resulted to substantial outflows from emerging markets like the Philippines. On the local front, slower economic growth and uninspiring corporate earnings contributed to the lack of conviction amongst investors. Foreign equity funds were net sellers during the year resulting to an outflow of USD1.2 bn.

The US Federal Reserve finally raised its federal funds target rate to 0.25%- 0.5% from zero -0.25% previously. The Federal Open Market Committee (FOMC) noted that further rate increases will be gradual and will follow the pace of the economy. The FOMC expects the fed funds target rate to rise toward 1.5% and 2.5% by the end of 2016 and 2017, respectively.

Financial markets continue to face strong headwinds from rising U.S. interest rates, strong US dollar, global slowdown and the May Presidential elections. These could create continued volatility and uncertainty in the near term.
