It also aims to surpass its benchmark which is the composite return of the Philippine Stock Exchange Index and the HSBC Local Bond Index. 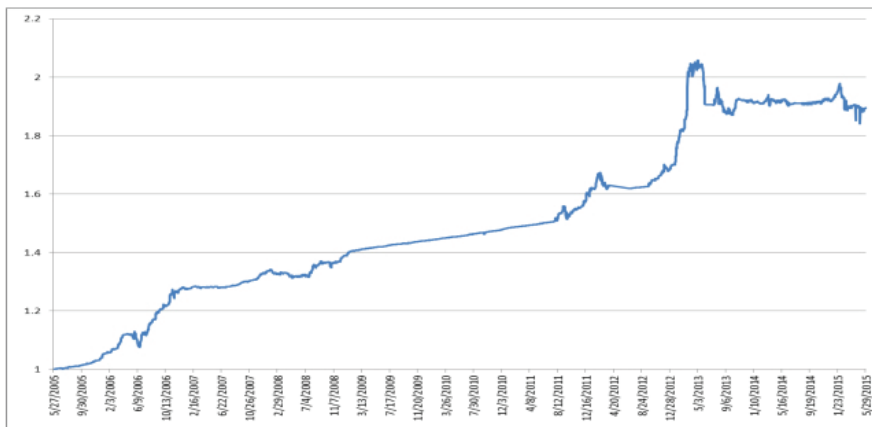

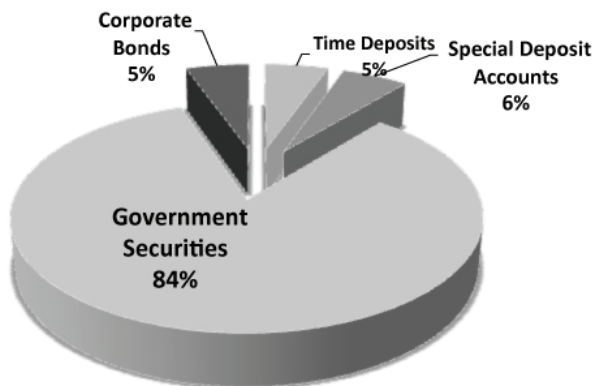

**RELATED PARTY TRANSACTIONS**

The Fund has deposits with the Bank Proper amounting to P25k which was approved by the Board of Directors. Likewise, all related parties transactions are conducted on an arm's length basis.

**OUTLOOK AND STRATEGY**

BSP kept the reserve requirement of banks, over-night borrowing rate and Special Deposit Account (SDA) rate steady at 20%, 4%, and 2.50%, respectively. The BSP's move was made on the back of a very benign inflation outlook and favorable growth prospects.

Headline inflation eased to a 20-month low in April to 2.2% from 2.4% in March due to stable food, fuel and electricity prices.

Remittances for March surged by 11% -- the fastest growth since Dec. 2009 -- to USD2.3 billion. Total inflows for the first three months of the year have now reached USD6.4 bn, 5.2% higher versus the same period last year.

1Q 2015 GDP grew by 5.2%, the slowest pace in more than three years. The slowdown was mainly due to continued underspending by the govt. and weakness in exports.

It was generally a quiet month for local bonds as investors remained on the sidelines due to lack of any fresh leads. The imminent hike in U.S. interest rates has kept investors, especially those trading fixed income securities, defensive. The prevailing consensus is for the U.S. Fed to start hiking rates by late this year.

We have positioned our portfolio in the short end of the curve -- with a duration of only 1.1 years -- as a defensive measure in anticipation of the upward move in interest rates.
