INVESTMENT OBJECTIVE AND STRATEGY

US\$BF intends to achieve for its participants an alternative investment outlet through investments in high-quality and credit worthy US Dollar denominated fixed income instruments. It also aims to surpass its benchmark which is the JP Morgan Asia Credit Index (Composite). This should not be construed, however, as a guarantee of yield.




** Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper amounting to \$12.6k, which were approved by the Board of Directors. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

As expected the Federal Reserve moved the Fed funds rate higher by another 25 basis points to 1.75% during the March meeting of the Federal Open Market Committee (FOMC). This is the 6th rate hike since the end of the global financial crisis and the 1st this year. While the Fed has emphasized that its decisions are data dependent, it is still almost universally accepted that the Fed will further hike rates as its desired Fed funds rate is still far, i.e., near 3%. Unsurprisingly U.S. dollar time deposit rates and bond yields have been inching higher.

However, in between this long term trend, the USD bond market could experience some surprises and bond yields could rally momentarily. Recent events have confirmed this observation. The brewing trade war and the continuing weakness of U.S. stocks have turned investors cautious. As in the past, a risk-off scenario has prompted many investors to move into U.S. Treasuries as safe haven outlet. As a result, U.S. dollar denominated securities – including our ROP bonds – have lately appreciated, at least for the moment.

We remain cautious as the long term trend still points to higher yields
