INVESTMENT OBJECTIVE AND STRATEGY

US\$BF intends to achieve for its participants an alternative investment outlet through investments in high-quality and credit worthy US Dollar denominated fixed income instruments. It also aims to surpass its benchmark which is the Bloomberg Barclays EM USD Sovereign Bond Index. This should not be construed, however, as a guarantee of yield.

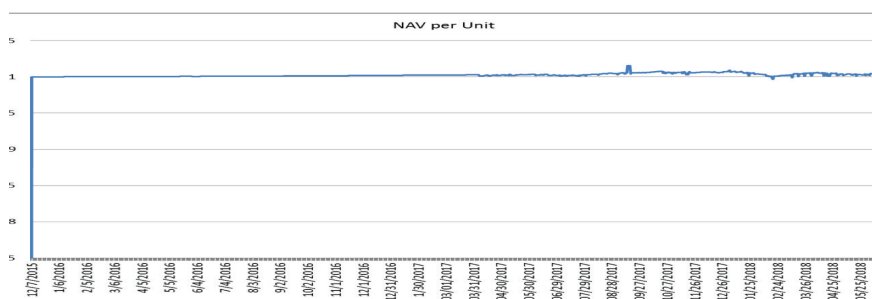

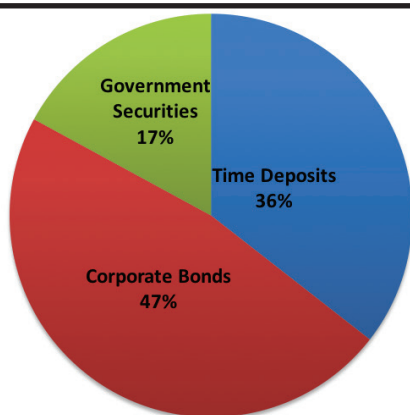
** Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper amounting to \$119k, which were approved by the Board of Directors. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

U.S. growth remains on track with the economy expanding by 2% in 1Q 2018. Unemployment has fallen to 3.8%, a level last seen in 2000, while hourly wages have been trending higher. Meanwhile, inflation has slowly climbed to 2.3%.

The Fed hiked its benchmark rate by another 25 basis points which brought the Fed funds rate to 2%. This is the 2nd rate increase this year the 7th made by the Fed since the start of its current tightening cycle. Based on projections made by Fed members there will likely be one or two more rate hikes for the remainder of the year.

We continue to remain defensive especially with our bond exposure given further rate hikes in the months ahead.
